ASSESSOR'S REPORT - Gary Raupp

Assessor Raupp reported to the Board:

1. His department has been working on senior applications for exemptions.
2. The assessment cards will be out August 15. It is much earlier this year than previous years. The final day for assessment appeals will be September 16.
3. By law the assessment appeal process was extended.
4. The state factor is .9833.
5. Appeals are down due to the increase in the home prices. There are usually 2000/3000 application for review per year and approximately ½ of the applications go to appeals.
6. Commercial vacancies are very high - there are approximately 150 commercial properties vacant.
7. State representative, Carol Sente will be giving a talk at the Sullivan Center on tax assessments.
