1. Curran Construction completed the blacktopping of Apple Hill Ln. and Port Clinton Rd. The pavement was widened 18" along Stevenson High School on Port Clinton Rd.
2. The Road District received a grant from the State for \$3400.00 for the lighting project in the garage.
3. The storm sewer project in Krisview is complete. They will be sodding when the weather improves.
4. New sod in Pekara Subdivision is in and the watering continues.
