HIGHWAY COMMISSIONER'S REPORT - Bryant Schroeder

Commissioner Schroeder reported to the Board:

1. The lighting project in the shop is complete. Annual energy savings should be approximately \$1500.
2. The Recycle-O-Rama event was a success. 30,000 lbs of electronics, 20 boxes of used books, 100 cell phones, 200 eye glasses, 504 pairs of shoes for recycling and 40 pairs for donation, 697 cans of paint, etc.
3. The recent bid for blacktopping was awarded to the low bidder, Curran. (copy on file)
4. His staff has been working on spring projects: grass cutting, garbage collection, etc. If weather cooperates they will commence the Krisview grounds repair.
5. He will be investigating options for repairs of the Township administration building roof.

ASSESSOR'S REPORT - Gary Raupp

Assessor Raupp reported to the Board:

1. Tax bills are out. Tax rates are up as values go down.
2. The county would like the certification of the assessment books in to the county by July 15.
3. Assessed value of the Township is down 5%/8%.
