Commissioner Schroeder reported:

1. Blacktopping is complete in Horatio Gardens and dirt and gravel restoration is proceeding.
2. The drainage ditch behind the Meadows Subdivision has been lowered to allow for a better flow of water.
3. The Krisview storm sewer bid has been awarded to the lowest bidder (Copenhagen Construction) (copy on file). There was a big difference in the 11 bids. High of \$398,000 to low of \$157,000.
4. The green parts washer in the shop is working perfectly.
